# MAY 14, 2019

The 9th Regular Council Meeting was called to order by Mayor James Waller after the Lord's Prayer & the Pledge of Allegiance were said.

Motion to approve the Minutes of the Special Meeting held May 7, 2019 was made by Councilwoman Stoller seconded by Councilwoman Boldizar. All voted yea.

Motion to approve the financial statement for the month of April was made by Mayor Waller seconded by Councilwoman Stoller. All voted yea.

Mr. Harp presented Don Luedtke with a watch in recognition of his retirement and 30 years of service to the village.

Administrator: Mr. Harp reported ODNR Park application is due. Mr. Harp stated due to the loss of CDBG funding and it was discussed that the village has a very good fund balance in our self-insurance fund to the point where we could take a couple months of premiums and move money into the capital improvement fund to help cover the W. Lincoln Way water line. The North Market Street grant is still active due to Issue II Funding, but is still a year out. Mr. Harp has started the county budget. Mr. Harp is waiting on a quote from Minerva Welding on the bridge in Brock Park. Mr. Harp & JT will meet with a representative from Ohio Bridge Corp. I think it is worth fixing. Pennsylvania Avenue water line project is complete. Councilwoman Stoller asked Dave if he received quotes for new computers. Mr. Harp stated he thinks Patti was working on that. Councilwoman Stoller asked Mr. Harp if he contacted Mr. Bieling about paying for the curb & gutter. Mr. Harp will try to get a hold of him this week.

Service Director: JT reported the paving bids are due next Tuesday. Reported on each service department. Councilwoman Stoller asked if the flagpole at Valley Street cemetery needs painted before Memorial Day. Councilwoman Stoller asked if the pool manager could get better stats. JT stated a new process will take place for admissions, passes & money. Also the park board meeting the sand volleyball will be starting the seed pods need cleaned out.
