#### RECORD OF PROCEEDINGS

#### 2<sup>nd</sup> REGULAR COUNCIL MEETING

### **JANUARY 22, 2019**

The 2<sup>nd</sup> Regular Council Meeting was called to order by Mayor James Waller after the Lord's Prayer and the Pledge of Allegiance were said.

Guests: Denise Freeland, Chris Miller, Patti Willoughby, Linda Cowden (Historical Society) Brent Cowden, Darlene Lutz, Eleanor Carson, Jeff & Melissa Fletcher, Adam & Amanda McCrobie, Birch Billiter, Arthur & Rebecca McClish, Mark Daily, Darlene Billiter & Vanessa Cercone.

Linda Cowden representative of the Historical Society reported on projects and improvements that are happening at the Haas Museum. Grand Opening will be May  $18^{\rm h}$ .

Denise Freeland stated renewed the contract with the company that they lease the rights to show the movies. State of The Village will be January 31. May 18 Art & Jazz Festival. February 2 Pop Up Shop. They received a grant check from Arts N Stark to perform Steel Magnolias. State of The Village Luncheon will be January 31.

Melissa Fletcher & Birch Billiter spokes persons for the group of Middle School Wrestling parents. An incident took place during the end of practice with a drill that happened with one of the wrestlers on December 14, 2018. Two coaches have been charged with a crime. Birch Billiter stated the parents were advised by the medical team to file a report, because the medical team would be doing the same. As far as we understand both reports were filed. Then the Minerva Police Department did an investigation which led to the Prosecutor pressing charges on two of the coaches. Melissa stated we are not here about the family that is pressing charges we are here for what happened after that. How it affected our boys after that. This incident happened December 14 and we were not made aware of this incident until December 17 & 18. The parents were under the understanding this was a school board investigation not a police investigation. Melissa presented a school board policy Code PO5540. Chief Miller did speak with Mr. Chaddock and the principal to ask for permission to interview the students. Chief Miller stated we received a complaint, we investigated it. I went with our legal department to the prosecutor's office to make sure we did this right. We went over the next Monday morning to talk to the 16 potential witnesses. These kids were never suspects. We needed to talk to them before stories got conflated with all the inaccuracies. Nobody knows this case but me and my two officers and the prosecutor. Melissa asked why it took so long from Friday to Monday to talk to the students. Chief Miller stated the report was not filed until Saturday morning around 2 am. Mr. Billiter asked why the parents were not notified. Chief Miller stated because we had to talk to the children. Mr. Billiter stated so you feel you have the right to talk to our children without our consent. Chief Miller stated in that case we did. Mr. Billiter stated you are incorrect! (Everyone is talking at one time). (Everyone is yelling) Melissa stated a we are asking is that we don't say know the school board says wait and contact the parents. But we should have had the right to protect our children. Councilman Hannen asked if the school gave a reason why they broke their own protocol. Melissa stated no. The recognized it. Atty. Battista stated the school board policy is not applicable to the village. Chief Miller stated on Monday morning we went to the school we advised......Mr. Billiter stated the school board told them the school policy supersedes his policy. Chief Miller let me speak this is how it happened..... we went over Monday morning to advise the school of the complaint we received over the weekend and advised them we needed to talk to these 16 kids. They asked us if they could get their counsel. We waited until their lawyer came from Canton  $au_0^\dagger$ permit us to talk to your children. Mr. Billiter asked in that time maybe you should call the parents. Chief Miller stated I know you don't like that, but we don't need too in that situation. It is school board police and we have a copy stated Birch! Chief Miller stated we went through the schools legal counsell Birch stated they were told by Mr. Chaddock that they made a mistake in not contacting us. Chief Miller stated then you need to talk to Mr. Chaddock. Atty. Battista stated he heard the statement the village police department is obligated to abide by the schools policy. I will review that. My initial thought is that does not make sense. Atty. Battista spoke with the prosecutor and their position the Minerva Police Department investigation was proper. Councilman Tarbet stated the school was given the opportunity to enforce their policy. Melissa agreed they had time to enforce it. Councilman Tarbet stated when Chief Miller walked in on Monday the school had the opportunity to say our policy says......Birch stated yes and they (school) has admitted to making a mistake. Councilman Tarbet so to clarify the school had the opportunity to tell them you can't proceed with this until we fulfill our policy right. So that opportunity was there.....so the school board or school administration made the decision

then through their legal counsel that they were not going to do that. Am I getting the progression right? So at that time they took the responsibility right.....that they are going to allow your kids to be interviewed by the police department without your notification. Correct? For the most part ya stated Birch. So at that point whether our SRO knew of the policy or not that opportunity to enforce their policy was presented and they opted not to do that. Atty. Battista stated this department is the Chief's for the Chief to run and he would not be bound by a school board policy. The Chief operates it under the law. Melissa stated upon reviewing her sons interview she felt the questions were leading. When you ask the same question in more than one way it can be confusing. As a parent I have the right as to whether my child is interviewed. If the interviews would have been handled differently we might not be in this situation with the press. Councilman Hannen asked Melissa how you think the press was notified. I am pretty sure the school nor the police department would have contacted them stated Councilman Hannen. Birch stated we contacted the Minerva Leader. Birch stated the prosecutor could have. Chief Miller stated I will tell you how they found out....by reading the court dockets.
