	Guests: Bill Green, Superintendent of the Stark County Board of Developmental Disabilities. March is Developmental Awareness Month. Mr. Green explained the program.
	Aaron Stoller, Fire Chief stated he has received two bids for the sprinkler system for the fire station. The sprinkler system will be handled in two stages. The radio system- the old system has been turned off except for two sites so the trach trucks can communicate with each other. Aaron stated he had a conversation with Daryl Anderson we are receiving anywhere from 1700 to 3000 push to talks through the tower. They still owe us to more talk pass. They took our site down for maintenance and thought dispatch would be able to hit the Kensington site, but that is not the case. Not even signal strength from the tower out back. There is less than 1% the generator will fail, but that 1% is too much. We would be out of communications for 2 hours. The fire department has a backup system but the PD does not. B&C is working on the fix. Chief Miller and I will have a discussion on this matter.

	Service Director: The water department has been in contact with Palmer Excavating regarding the Pennsylvania Water Line Project. Pre-construction meeting will be later this week. Plan are ready to be submitted to the EPA for the Lincoln Way Project. Park Dept. attended a service training for the Jacobson Mower. Checking on street department generator.
	Law Director: Atty. Battista stated everyone should have a copy of the new employee handbook and advised council to review it and make notes of corrections.
