2ND REGULAR COUNCIL MEETING

January 28 2019

The 2nd Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Lord's Prayer and the Pledge of Allegiance were said.

All Council Members present.

Guests: Tom Lynch, Aaron Stoller & Patti Willoughby

Tom Lynch addressed Council regarding a parking issue at the corner of N. Market St. & W. 1st St. The tri-plex provides two parking spaces, but at any given time there are 7-8 cars which will block the end of his drive. Tom stated they have called the police and were told if you can get out of your driveway it's not really an issue and we cannot do anything about it. There is also a sign placed to prevent parking next to the stop sign which they are not doing. They also use his drive as a turnaround. I would like it addressed by painting two spots on the road designating no parking. Tom researched the allowed amount of space and it states 5ft. from the drive. The village would have to pass legislation to support this. Mayor Tarbet stated we will take a look at it and see if we can't do some things to assist with this problem.

Motion to approve the Minutes of the 1st Regular Council Meeting held January 14 2020 was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea.

Administrator: Mr. Turske stated we should have the next iteration of the handbook back this week or next. Mr. Turske asked that workshop on February 11 start at 6:15PM. Mr. Turske would like to discuss the fee study. Cruiser and upfitting are on the agenda.

Service Director: JT reported the water department Contingency Plan is updated & revised and will be submitted to the EPA on 1-31-20. Asset Management Plan is nearing completion and is due 1-31-20.

Well #1 motor and pump pulled by National Water to prepare for camera inspection and flow test. Motor and pump were both determined to be bad and need to be replaced if well would be put back in service (estimated to have been installed in the 1950s or 1960s). Well was shallow (approximately 45'). Steve Couch contacted Steve Jackson, from what he remembered, was that water was bad (high iron content) and they were preparing to drill wells #3 & #4. The well was run until something broke (motor or pump) and nothing was done with it due to quality of water. Ball park cost to put well back in service is \$53500 -\$70000. Recommend that Well #1 be abandoned by the Plan of Action filed with the Ohio EPA on 10/04/19 (abandonment due 03/31/20).

Minerva Dairy waste water surcharge is ready to be billed for period of 12/12/19 - 01/15/20 however Minerva Dairy has not filed self-monitoring reports with the village by 01/20/20, Ohio EPA notified. Minerva Dairy had additional slug discharges 1/14, 1/15, 1/17, 1/21, 1/23 and 1/27. Made contact with Adam Mueller 01/27/20 at during discharge, advised they would make adjustments.

Nothing further to report from Ohio EPA reference the dairy issue.
