## **4TH REGULAR COUNCIL MEETING**

#### **FEBRUARY 25 2020**

The 4<sup>th</sup> Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Lord's Prayer & the Pledge of Allegiance were said.

All Council Members present.

Motion to approve the Minutes of the 3<sup>rd</sup> Regular Council Meeting held February 11, 2020 was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea.

Administrator: Mr. Turske reported we are working with the Carroll County Engineer regarding the Zeedrich Dump Road Maintenance Agreement. This is turning into a bigger bear than we thought. The County Engineer has concerns about the route and the integrity of the roads holding up on his part and on ours. Northrop Grumman sent a road maintenance agreement and we went back & forth with comments, they did not like our comments so they put it back to the subcontractor making it their responsibility to enter into an agreement with the village for the road maintenance. Mr. Turske stated he informed them we are not doing that. We want that agreement with Northrop because they have more money. A subcontractor goes out of business and leaves no recourse to hold them accountable. So, we are asking for a maintenance bond, a preconstruction video so we will work with county engineer. Brown Twp. Has already signed off with their agreement. Mr. Turske stated the Envision Minerva took place last week. The turnout was not what was hoped. The ideas were solid. I would encourage as many residents attend.

Service Director: It reported 408 ton of salt has been used or stored. We pre-ordered 1000 ton we are required to purchase 800 ton by July 31 the village will be charged \$15 a ton for the State to store it.

Scheduling Well #1 abandonment (EPA resolution due by 03/31/20).

Backflow program implementation response to EPA from January 1, 2020 submission. Response submitted 02/24/20, EPA accepted deadline of May 29, 2020 for Minerva Dairy cross connections issues to be resolved. Minerva Dairy notified. 50 of 58 backflow devices on village are current, 2<sup>nd</sup> notice of violation and shut off notices to be sent for remaining 8 locations. Locating water distribution assts for Miller Pipeline for gas line replacement. Received contract from RCAP for consideration for GIS mapping of water system. Lucas Bettis started February 17<sup>th</sup> in the street department. Corresponding with Ohio EPA reference to suit filed against Minerva Dairy and their discharge violations. Assisting Miller Pipeline with sanitary survey for gas line replacement in N. Market area.
