The 18th Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Lord's Prayer & the Pledge of Allegiance were said.

Denise contacted Kelli Betler of Colfor to see if a relief fund had been set up for the employees of Colfor due to the devastating fire the Malvern Plant sustained this morning. Kelli will contact Denise when information comes available. Denise reported on upcoming events. The Duck Race fundraiser for the Roxy will be held this Saturday. Mrs. Doubtfire was shown at the Roxy with only three people attending. Scarecrows in the Park will be held. Downtown Wonderland will be renamed this year December Wonderland with activities being held throughout the month of December to keep in compliance with the COVID guidelines.

Motion to approve the Minutes of the 17th Regular Council Meeting held September 8, 2020 was made by Councilman Kishman seconded by Councilman Boldizar. All voted yea.

Administrator: Mr. Turske announced Phase II N. Market St Project cost estimate is \$296,000. (1st to East St.) OPWC/Grant/Loan. The village is working with a consultant regarding cemetery GIS Mapping. Mayor Tarbet asked if individuals will be able to identify available lots to purchase. Mr. Turske stated he will contact the consultant.

Service Director: Street Dept.: Repairing catch basins. Begin mosquito spraying 9/8. Spraying every two weeks. Assisting Park Dept. with handicapped swing installation in Bicentennial and Brock Parks. Will pave area then cut asphalt for installation. Inspected log jam in Sandy Creek between Shallow Run and N. Market St. Stark Parks owns the parcel that several trees fell from, permission received from Rick (Operations Manager) to clear log jam and place trees on their property.

Water Dept.: Working w/ Regional Planning on GIS mapping. Plant pumped 1100 gallons of water per minute from 6 AM until after 1PM to supply fire dept. with water for Colfor fire.

Waste Water Dept. Determined August violations were caused by solids processing. Monitoring sludge press filtrate for ammonia content. MLSS is around 4000 mg/l however settleability still poor.

Park Dept, Installing two handicapped swings donated by Minerva Rotary and Catlett Construction in Brock and Bicentennial Parks. Waiting on paving (roller inoperable). Repaired damage/vandalism to train cars for 2nd time this year. Raised ground level around slide to correct height (see photo) and installed rubber mat.

Zoning: Training with iWorQ zoning/nuisance software every Wednesday, live date scheduled for 10/12/2020.
