DECEMBER 8, 2020

The 23rd Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Pledge of Allegiance & The Lord's Prayer were said.

All Council Members present.

Mayor Tarbet announced Village Hall is closed due to COVID, but all services are available.

Motion to approve the Minutes of the 22nd Regular Council Meeting was made by Councilman Kishman seconded by Councilman Hannen. All voted yea.

Motion to approve the financial statement for the month of November was made by Councilman Boldizar seconded by Councilman Kishman. Al voted yea.

Motion to approve bills for the month of November totaling \$369,270.99 was made by Councilman Meadows seconded by Councilman Hannen. Al voted yea.

Administrator: Mr. Turske reported the budget is being completed. District 19 Public Works Integrating Committee met to review nominations for funding of the next round of OPWC. We submitted an application to do N. Market Phase II. The villages application was the districts first recommendation down to the State Small Government Funding. They will be in contact with the village in the next few months with their decision. I want to thank the Fire Department and Chief Stoller to disinfect village hall. Service Director: Street Dept.: UST inspection completed 11/24/2020. Service Director attended training and passed certification tests for Class A and B UST Operator, We will train and certify one additional employee. Contractor still needs to complete triennial tests following probe and spill reservoir repairs. Snow/ice control 12/01. Called out 0230 hrs. and 1830 hrs. Leaf pick-up will continue weather permitting. 57 loads to date, 51 disposed of at Bowman's Tree Service.

Water Dept.: 8" main break 800 block of Grant 11/27, assisted by Park Dept. Assisted PCC in meter replacement and service line repairs.

Waste Water Dept.: Minerva Dairy had slug discharges 11/25 and 11/28. Conference calls were held with Ohio EPA 11/25 & 11/27 with follow-up information submitted 11/30.
