generalism by	Aaron reported due to the generosity of West, Paris, Augusta and Minerva we received \$66,000 in CARES Act Subgrant funds. \$3300 went towards PPE. And other valuable and much needed equipment. Aaron also stated our local hospitals have approximately 230 COVID patients. Some of the nursing homes are excepting those stable patients. The past two weeks the spread in this area is 85 and 220 in the past thirty days. Live training for the Steramister will begin the first of the year. First responder vaccinations probable will not happen until the beginning of the new year. The first responders will not be getting the Pfizer vaccination, so it will not be mandatory at this time. You will have to go to the Health Department.
