	Motion to approve bills totaling \$298,834.00 for the month of January was made by Councilman Kishman seconded by Councilman Boldizar. All voted yea.
	Administrator: Mr. Turske reported the OPWC Application for N. Market Phase II Funding has been submitted. They have sent the application to the State for small government funding, which would allow the village to make changes to the application if we see fit. We added more information to the application and sent it yesterday. If the submitted application is selected, the village would receive \$145,000 in grant funding from the State. Mr. Turske thanked JT and the street department for removing the snow uptown. The village will not be renting pavilions this year. Proper documentation will be put out to the public. It will be a first come first serve. Porta-Johns will be available and trash will be collected one time over the weekend.
	Service Director: Street Dept.: Repaired oil leak on roller. Called out for road conditions 1/28, 1/31, 2/1, 2/9. 632.41 tons of salt used for season to date (Cargill Pre-Order 800-ton, minimum order is 640 ton). Removed snow piles from uptown area. Water Dept.: Locating assets for GIS mapping. Met with contractor to get updated quotes for interior and exterior storage tank coatings. 1 MG tank scheduled for exterior and .5 MG scheduled for interior this year. Both will be bid out due to anticipated cost. 1 ½" iron water main break on N. West St. 2/8. Assisted by Park Dept. Line appeared to be in poor condition (heavy scale) and should be replaced. Feeder line provides service to 3 properties. Waste Water Dept.: Slug discharges noted: 1/27, 1/28, 1/30, 2/1, 2/2, 2/3. Samples obtained from Minerva Dairy. Minerva Dairy reported biomass died due to pH imbalance. Notice of Suspension issued 2/3 with disconnection set for 2/4 if dairy was unable to control discharge and become compliant. Had several telephone conferences with Ohio EPA. Dairy became compliant 2/4 and notice of suspension rescinded per ordinance. Clarifier #1 began bulking 2/5 at approximately 1200 due to high MLSS (solids). Adjustments made to return rate and wasted additional 20000 gallons sludge. Total wasted for week of 2/1 was 75000 gallons. Agri-sludge hauled 100000 gallons of sludge offsite due to high solids intake. Press has been down part of December and January due to polymer supply issues and plant has been unable to press. Replaced roller bearing in sludge press. Park Dept.: Working on winter maintenance items. Misc.: Completed US Census 2021
