JANUARY 26, 2021

The 2nd Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Lord's Prayer & The Pledge of Allegiance were said.

All Council Members present.

Guests: Denise Freeland announced the Chamber is offering the Roxy for private movie rentals at a fee of \$75. This is for 20 people and the renter would provide their own DVD, popcorn is provided. The Chamber received a donation from Annette & Stuart Mapes and State Farm Insurance. State Farm sponsors a program where the Mapes made a donation and State Farm matched the donation. The donation will be used towards organizational equipment and items for the concession stand. Upcoming events: March a Celtic Show & possibly live streaming a radio drama at some point this spring. The next play will be in February 2022. The Jazz Fest will be planned, but will be altered. A new insurance & financial service agent that would like to relocate to Minerva. Green Carbon International are working on their financing. Plan discussion with Mark Hollingshead rep Green Carbon and Raphael from Stark Economic Development Board and a rep from Team NEO. Mark presented his plan and discussion took place regarding the financing that was available for the project.
