Mayor Tarbet announced the next regular council meeting will be December 21 2021.
Motion to approve the Minutes of the 22 nd Regular Council Meeting held November 23, 2021 was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea.
Motion to approve the Financial Statement for the month of November was made by Councilman Meadows seconded by Councilman Kishman. All voted yea.
Motion to approve bills totaling \$393,545.78 for the month of November was made by Councilman Meadows seconded by Councilman Kishman. All voted yea.
Administrator: Mr. Turske announced if residence go to the village website or the village Facebook page, we have posted the Columbia Gas quarterly report update which includes information regarding help with winter bill assistance and winter safety messages. The new and updated employee handboo will be handed out to the employees before the holiday break. The new parking program regulations will be posted on the village website. Businesses will be notified of the upcoming changes. Parking meter collections will start January 1 2022. And with that said, we are putting in the parking program that will include purchasing parking passes that will allow business owners or residents to park in designated areas without feeding a meter.
Service Director: Street Dept.: Set up Christmas decorations. Leaf pick-up continues. Repaired electrical issues uptown. Had a resident on E. Line St. request replacement of storm sewer, advised storm sewer from Park St. to Murray Ave. is clay tile pipe and has not worked properly in 25 years. Spoke with D. Galay who advised E. Line St. storm sewer empties into catch basin at E. Line St. and Murray Ave. then crosses street to south side of roadway and empties into creek. Advised one catch basin on south side of roadway does not have an effluent line for unknown reasons. Called out for road conditions: 12/8. In process of installing parking signs uptown.
Water Dept.: Finishing ERP for AWIA requirements. Began RCAP asset management monthly worksho to revamp asset management plan into a working plan. Colfor planning on installing 6" water main to new building. Met with contractor several times.
Wastewater Dept.: Clarifier #2 back online. Completed Minerva Dairy surcharge for October 2021, 1 TSS violation on 10/2, 852 lbs., \$374.90. Blower motor removed for repairs.
Park Dept.: Graffiti observed in Municipal and Brock Parks 12/1 (Band shell, bridge, both dugouts and pavilion). Report filed with PD. On 12/7 Park Superintendent noted car parked in high school lot with same "tags" (markings) in shoe polish on window, reported to PD. PD investigated and charged juvenile, provided estimate of \$673.09 to remove graffiti. Tire swing installation complete in Bicentennial Park.
Cemetery: Valley St. cemetery fence repair quote \$1520.00 from White Lightening Fence. Entire Valle St. frontage \$12785.00 w/ commercial grade aluminum fence. Southway fence did not respond to tw requests for quotes. Hilles quoted \$552.00 to reset base two stones and two monument stones.
