Mayor Tarbet introduced Superintendent Gary Chaddock. Mr. Chaddock introduced the first State team title winners in Minerva's history, the State Champions Girls Cross Country Team. Jenna Cassidy represented the team by saying that when they started out, no one thought they would be state champions. But they started realizing how good they were and when they beat the #2 team at regionals, they knew they could pull it off. Councilman Kishman congratulated the team and asked where the seniors were planning on attending college to which they all answered they were undecided. Councilman Boldizar has hung out with the group for the last few years and stated that it was very special being at the meet. The meet was awesome and the parade was awesome. There were about 200 Minerva area residents in attendance to which he noted, "That's what we do. We support our teams". He noted that they won by 3 points and made us all very proud. Councilman Meadows congratulated the team and said that the energy at the school was due to their accomplishments and it's amazing. Mayor Tarbet had listened to the teachers saying how dedicated they've been and their commitment is amazing. He said when they realized how good they were, they took that to state. They should be proud and they and their coach deserve to be recognized. That's why Mayor Tarbet wanted them to come to Council. Hydrant install, paving and other cosmetic issues remain incomplete. Wastewater Dept.: Reviewed and issued letter not objecting to Minerva Dairy application for PTI with Ohio EPA. PTI is for DAF process, rotary screen and enclosure. Installed riser on Concord Dr.

Park Dept. scheduled tire swing install at Bicentennial Park for 11/23. They excavated area required for install. However a part of the frame wasn't right and the manufacturer will have to be contacted. Minerva Welding attempted to install Bicentennial Park bridge however crane got stuck.

Motion accepting the proposal of, and entering into an agreement with, Whitaker Myers for the Minerva 2022 property, casualty, and automobile insurance program, in an amount not to exceed \$45,817.00 was made by Councilman Meadows seconded by Councilman Boldizar. All voted yea. Administrator Turske explained that this is for our property, casualty, and automobile insurance which is up on December 13. We solicited proposals. Whitaker Myers is not the lowest priced of the proposals. However, USI Insurance, which had the lowest price, did not offer cyber insurance and they have a different way of processing claims when the contract is up. Whitaker Myers offered the best all around program. Administrator Turske wished everyone a Happy Thanksgiving. Councilman Kishman also wished everyone a Happy Thanksgiving and hopes that people get out to shop on Small Business Saturday and they come to see Santa and Small Town Wonderland. Councilman Boldizar congratulated the Cross Country Team again and encouraged all to attend Small Business Saturday. He noted that a lot of different things are opening up. He said that the Envisioning Workshop was really neat. The ladies running it did a fantastic job and were engaging. He ended with, "Go Buckeyes!"
