Guests: Aaron Stoller

Aaron Stoller thanked the community support for passing the levy renewal for the next five years. The FD has grant money they need to spend by the end of next year. Still waiting on the ambulance delivery date.

Motion to approve the Minutes of the 8th Regular Council Meeting held April 26, 2022 was made by Councilman Kishman seconded by Councilman Meadows. All voted yea.

Motion to approve the financial statement for the month of April was made by Councilwoman Jordan seconded by Councilman Boldizar. All voted yea.

Motion to approve bills totaling \$410,837.29 was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea.

Administrator: Mr. Turske announced the Jazz Fest will be Saturday, along with the first DORA Event. The participating four establishments are Sandy Springs Brewery, QuePasa, Bings and the Normandy. Rules of the DORA are you purchase your normal drink and for a dollar more you receive a disposable DORA cup which allows you to walk from the train tracks Market all the way to 30 and High St, Main to Short from 12-7. The cups are single use. A map will be displayed. Spring Clean-up is May 21.

Service Director: Street Dept.: Installed traffic signal loop on N. Market St. at US 30. Installing footers in cemetery for markers. Topped graves in East Lawn Cemetery and planted grass. Detour will be set up Friday

Water Dept.: Continuing asset management program with RCAP. Presentation to council June 28. Cross Connection Control training completed 4/29. Fencing complete at both water towers. Replacing water trunk line in bath house.

Wastewater Dept.: 4/28 1 of 2 return sludge pumps failed. On 4/30 2nd sludge pump failed. Used a 3" gas trash pump and a 2" electric pump to attempt to keep up with return required from clarifiers. 5/2 obtained 6" diesel trash pump from E-Pump to maintain system. Both sludge pumps installed in 2014, one was serviced 2019. New pumps should last 15 years with replacing seals and bearings every other year per Berger Electric. Minerva Dairy surcharge for March 2022: 9 days in violation surcharge in amount of \$1401.42.

Park Dept.: Repaired lift arm on Jacobsen. Sprayed uptown area/sidewalks with weed kill.

Pool: Gas service reconnected. Paint delivered; Mahon scheduled to begin painting this week.
