22ND REGULAR COUNCIL MEETING

NOVEBMER 22, 2022

The 22ND Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Lord's Prayer & Pledge of

All Council Members present.

Motion to approve the Minutes of the 21st Regular Council Meeting held November 8, 2022 was made by Councilman Boldizar seconded by Councilman Kishman, All voted yea,

Denise Freeland reported that Bob Harris & other volunteers are working on getting the seats ready that they received from the Carnation Cinema. Marshall's Antique Warehouse is interested in the old seats. The furnace is hooked up and the walls are ready to paint. They received funding from the Visit Canton Grant. They approved all except the electrical work. Denise will look for other grants for that. Small Business Saturday is November 26. There are 21 businesses participating and 3 pop up shops. Maps are on Facebook and at businesses. Downtown Wonderland is December 3. The parade will be at 3 and the tree lighting at 6. There will be many activities. Minerva Perk and volunteers are decorating Mayor's Park for the tree lighting ceremony. Denise also noted that 12 Days of Christmas raffle tickets are on sale.

Administrator: Administrator Turske reminded residents that Village Hall will be closed on Nov. 24-25. He had a meeting with ODOT regarding the bridge over Sandy Creek. ODOT will repair/replace the bridge in the summer of 2023, though no dates have been set yet. There will be a 60-day closure. ODOT will pay for this entirely. We received 2 NatureWorks grants. One grant is to add a parking lot at Rotary Park and the other is to replace play equipment in Municipal Park.

Motion to accept the resignation as submitted to Council of Administrator Turske was made by Councilman Meadows seconded by Councilman Kishman. All voted yea, Mayor Tarbet offered congratulations to Mr. Turske.

Ordinance No. 47-22 an ordinance amending Ordinance 44-21 (annual appropriation ordinance) in order to make appropriations for expenditures of the Village of Minerva, Ohio during the current fiscal year ending December 31, 2022, and declaring it an Emergency. First Reading

Motion to hear first reading of Ordinance No. 47-22 was made by Councilwoman Jordan seconded by Councilman Boldizar.

Motion to approve first reading of Ordinance No. 47-22 was made by Councilman Kishman seconded by Councilman

Motion to suspend statutory rules of Ordinance No. 47-22 and have second and third readings by title only and for passage was made by Councilman Boldizar and seconded by Councilman Meadows. All voted yea.

Ordinance No. 49-22 Consent Legislation. The following is enacted by the Council of the Village of Minerva of Stark, Carroll and Columbiana Counties, Ohio, hereinafter to as the Local Public Agency (LPA). First Reading

Motion to hear first reading of Ordinance No. 49-22 was made by Councilman Kishman seconded by Councilwoman Jordan. All voted yea.

Administrator Turske explained that this is for the ODOT replacement of the Lincolnway Bridge by the Fire Department. ODOT will bear the full cost. Presumably it will be sometime in June-October, 2023. Motion to approve first reading of Ordinance No. 49-22 was made by Councilman Meadows seconded by Councilman

Motion to suspend statutory rules of Ordinance No. 49-22 and have second and third readings by title only and for passage

was made by Councilwoman Jordan and seconded by Councilman Kishman. All voted yea.

Motion to close North Market St between Rt. 30 and Line Street, and High Street between Main and Market on December 3, 2022 from 2 pm to 6 pm at the request of the Minerva Area Chamber of Commerce for the Christmas Parade and Downtown Wonderland was made by Councilman Kishman seconded by Councilman Meadows. Administrator Turske explained that this was approved previously but this updates the time and the streets to be closed. All voted yea.

Motion to approve the write-off of \$332.54 being carried over monthly on the bank reconciliations resulting from an overpayment in September 2021 on an employee wage attachment order. The amount has already been paid to the employee's former spouse and is deemed uncollectable was made by Councilman Meadows seconded by Councilman Kishman, Finance Director Patti Willoughby explained that while our current Payroll Clerk was out of the office on sick leave, we had another person come in to do payroll. This person neglected to inform Expertpay about the fulfilled obligation and the money was withdrawn from our account. There is no way to retrieve this money. All voted yea.

Motion to cover the parking meters from December 1 – December 31 was made by Councilman Kishman seconded by Councilman Boldizar, Discussion was had that anyone who had prepaid for a pass in December would be able to carry over that pass to January.

Motion to set the meeting for the 2023 Appropriations Budget for November 29, 2022 at 6 pm was made by Councilman Meadows seconded by Councilman Kishman. All voted year

Motion to enter in to Executive Session at 8:18 pm to discuss employment or compensation with no action taken upon return was made by Councilman Kishman seconded by Councilman Boldizar. All voted yea.
