2ND REGULAR COUNCIL MEETING

JANUARY 24TH 2023

The 2nd Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Pledge of Allegiance & the Lord's Prayer were said.

Motion to approve the Minutes of the $1^{\rm st}$ Regular Council Meeting held January 10, 2023was made by Councilman Kishman seconded by Councilman Boldizar. All voted yea.

Service Director: Street Dept.: Bowman Tree Service removed 2 dead trees from East Lawn Cemetery. Removed 3 additional trees in poor health in East Lawn Cemetery. Trimming trees in right of way on N. Market St. Cleaned up downed tree from storm damage on Walnut between Jackson and McDowell. Removed downed tree from storm damage in alley off S. Main St. Need to replace backhoe fuel tank housing due to corrosion, part is discontinued. Custom Bus is making housing. Cold patch being used in potholes as needed.

Water Dept.: Ohio EPA Sanitary Survey inspection 01/18/2023. Filed grant application for H2Ohio Initiative grant 1/20/2023. Stark County RPC received bids on Euclid water replacement project. Completed Source Water Protection Plan survey as required by Ohio EPA. Continuing to work on Source Water Protection Plan for EPA review.

Wastewater Dept.: Renewing NPDES permit. Waiting on flow switch for polymer application for press. Running press manually. MLSS 5910 mg/l. Wasted 75000 gallons week of 1/16. Minerva Dairy has discharged excessive solids in violation of their limitations 18 days in January to date. Warning email issued to Minerva Dairy 1/24. Minerva Dairy surcharge for November 2022 was \$2044.68 for 6 TSS violations.

Park Dept.: Construction of Brock Pavilion completed. Cleaned up 4 loads of sticks/branches in Parks. Cleaned up numerous downed trees from storm 1/19. Working on confirming quote pricing and obtaining contract for park cameras project.

Resolution No. 2-23 Authorizing the Finance Director to move monies from one line item to another within funds that are solely designated as allowable transfers by the Auditor of the State of Ohio and the Ohio Revised Code. Motion to table accepting the quote of LetterGraphics Sign Company for engineered drawings, manufacture, transport and installation of the "MINERVA" sign in an amount not to exceed \$34,500.00 was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea. Mayor Tarbet stated this the signage project we have been working on for a while. We are just not quite ready to pull the trigger on it. We are not dropping it we are tabling it temporarily.

A Motion is in order to approve Kimble Refuse to conduct the Village wide annual spring cleanup in an amount not to exceed \$17,000.00 on May 20, 2023 was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea.

A Motion is in order to purchase a replacement screen compactor for the WWTP from Duperon Corporation in an amount not to exceed \$19,500.00 was made by Councilman Boldizar seconded by Councilman Meadows. All voted yea.

A Motion is in order allowing the Service Director, James Williams, to advertise and accept bids for the 2023 Cemetery Mowing Contract was made Councilman Kishman seconded by Councilwoman Jordan. All voted yea.

Motion to form a Wayfair Sign Project Committee was made by Councilman Meadows seconded by Councilman Kishman. All voted yea.
