3rd REGULAR COUNCIL MEETING

FEBRUARY 14TH 2023

The 3RD Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Pledge of Allegiance & the Lord's Prayer were said.

Guests: Denise Freeland & Fire Chief Stoller.

All Council Members present.

Denise met with Barbara Moran, the interior designer about colors at the Roxy. Painting was done on the 20th & 21st. Bob Harris is installing woodwork. Chris Lesho is ordering the sound system. After the completion of these tasks the occupancy permit will be applied for. Celtic Show is March 25 and Bob said it will be performed at the Roxy! Denise updated her calendar of events. Columbia Gas has created a grant which needs to be a 5013C. I suggested the funds go to the Minerva Area Charitable Fund. People are looking for retail space. Carroll County Economic Development & Ohio Southeast will meet with a local business owner looking for new resources.

Fire Chief Stoller stated he attended an incident manage assist team. A stand point from my end... it is an eye-opening experience to see such a large event in someone else's jurisdiction. It gives you a long list of things to do and a longer list not what to do. Most of you have heard there is significant train traffic on the West Twp. of Northfolk Southern. They are pushing 30 trains a day through that area. That rail can only take single high cars. Aaron stated he received a general email regarding water quality issues involving six states. We are nowhere near that intake. That information is being put out there. If you should have any questions, please ask me.

Water Dept.: Stark County Commissioners awarded Euclid Water Replacement Project to Palmer and Son Excavating in the amount of 171,104.30. Stark County Administering due to CDBG funds. Preconstruction meeting pending. 2/8 6" water main break 700 block Lynnwood Dr. Water loss. Village and RCAP will continue lead component service line surveys over the spring and summer. Residents requested to complete voluntary survey that is posted on the village website to reduce the amount of onsite surveys.

Wastewater Dept.: Minerva Dairy January solids issues. 22 days in violation of permit. 1/5 - 1/8 = 6805.89 lbs., 1/22 - 1/26 = 8435.36 lbs. Inquired about daily fines under 921.99 for those periods. Bar screen parts ordered and shipped. Minerva Dairy December surcharge 8 days in violation totaling \$2094.27.

Park Dept.: Cemetery mowing proposals due 02/28. Picking up limbs from recent wind events. Began demo of gazebo in Mayor's Park.
