### RECORD OF PROCEEDINGS

#### 11th REGULAR COUNCIL MEETING

#### JUNE 13, 2023

The 11th Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Lord's Prayer & Pledge of Allegiance were said.

Guests: Denise Freeland, Fire Chief Stoller, Police Chief Miller, Officer Tristan Roberts

All Council Members present.

Denise Freeland reported that they have had lots of positive feedback about how great our downtown area is. There are several upcoming events, including concerts, a dinner theatre, a hypnotist, and the homecoming. There is a ribbon cutting for the Grand Opening of Komfort Zone on June 14. Crosspointe Barbershop is moving to a bigger location in the building beside Que Pasa.

Chief Miller introduced new Officer Tristan Roberts. The Police Dept. has had an open, full time position for about 2 years. Officer Roberts graduated the academy last July and was a Park Ranger with the MWCD and a bailiff at Canton Municipal Court. Officer Roberts said that it's a great opportunity and it has been a pleasure working here. Council welcomed Officer Roberts. Chief Miller said that Officer Roberts is in Stage 2 of his training with Sgt. Gardner and is doing very well.

Chief Stoller mentioned that the flag disposal ceremony was cancelled and it will be rescheduled. Mayor Tarbet noted that Chief Stoller will be the emcee of the parade.

Motion to approve the Minutes of the  $10^{th}$  Regular Council Meeting held May 23, 2023 was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea.

Motion to approve the financial statement for the month of May was made by Councilman Meadows seconded by Councilwoman Jordan. All voted yea.

Motion to approve bills totaling \$227,171.88 for the month of May was made by Councilwoman Jordan seconded by Councilman Kishman. All voted yea.

Administrator: The Administrator reported that we received the invoice for Spring Cleanup and it was for \$13,750,.32, which was under budget. He mentioned that residents will begin receiving their electric aggregation letters this week. Administrator Gunderson stated that as of Monday, June 19, the Village will become the contact for the Community Building and its scheduling. He said that we will take care of the building also. He has been working with Denise Freeland on the Appalachian Community Grant and the architects are impressed with the progress. Lastly, he noted that they are taking a look at downtown zoning districts to protect ground floor spots.

Motion to hear first reading of Ordinance No. 48-23 was made by Councilman Boldizar seconded by Councilman Meadows. All Administrator Gunderson noted that the caboose has become a safety hazard. The CIC will donate it to a train museum and they will rehab it and use it. Motion to approve first reading of Ordinance No. 48-23 was made by Councilman Meadows seconded by Councilwoman Jordan. All voted yea Motion to suspend statutory rules of Ordinance No. 48-23 and have second and third readings by title only and for passage was made by Councilman Boldizar and seconded by Councilman Kishman. All voted yea. Fire Chief Stoller asked if there was any progress on the Route 30 bridge? Service Director Williams replied that they are expecting the bridge to be removed by the end of August. Fire Chief Stoller said that Council needs to think about water line replacements in the future. That we currently have some 2" and 4" lines. Councilwoman Jordan noted that the next Altercare Clinic will be July 25, as they are doing every other month. Councilman Meadows thanked everyone who came out to 2<sup>nd</sup> Friday. The businesses were busy. They would like more people to participate in events. He also noted that tickets for the dinner theatre on July 8 are on sale now. Councilman Kishman wished everyone a safe Homecoming week. He also welcome Office Roberts. Councilman Boldizar invited everyone to the Komfort Zone grand opening as they come to the parade and the homecoming. Mayor Tarbet said he agreed with what Councilman Boldizar stated and reminded everyone that the street will be closed for the parade. He mentioned a couple of car shows coming up, 1 in June, another in September. Mayor Tarbet noted that the Village is completely renovating Mayor's Park, including new landscaping. He also invited everyone to the ribbon cutting at the Komfort Zone. Motion to adjourn was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea.
