Downtown Entertainment Street (Pocket Park) \$100,000 Engineering is a must. There has been a fundamental misunderstanding what that pocket park is supposed to reflect. People just don't understand it. A few people have asked me if there is going to be a playground. There is clearly a misunderstanding! Matt suggests a Ferris Wheel. Nate suggested the mailbox be on the Ferris Wheel! Benjamin stated the rendering produced was about \$600,000. \$128,000 was for the stage. I see that as more of a working draft. I still intend on doing the community meetings with residents & businesses. This is something I am really pushing for stated Benjamin. I think it will be a huge asset to the downtown. It's a matter of timing and money. The conversations I have had especially with the people going through the Chase Bank Building, every single person wants to know when the formally known pocket park will be in effect. Everyone knows that's the draw! That will keep people here. When you create a place to keep people, they have a reason to stay stated Benjamin. Oil & Gas Money maybe a chunk of that towards this or that. In my mind that is a one-time strategic money so, in that if we were going to put \$100,000 towards a 3.7 million sewer press is that really maximizing that one-time sum. In my mind with the projects going on right now, I would love to see \$170,000 go towards the Pocket Park. So, I want to see what councils thought are. I wish Mason was here for this part, because I know he feels strongly and in the same direction. He wants to put every penny we get towards that pocket park. I would love to have that allocated by the end of the year and here are the levels on that piece of pie. In 2025 start construction. I did build \$100,000 of that 2025 Capital Fund towards that. Assuming Council would agree. Engineering, Splash Pad (Brock Park), \$80,000 Bi-Centennial Basketball Court, \$70,000 Benjamin stated I want to redo the walking path or BB Court/Tennis Courts. My plan is to affix this to the paving schedule and apply for the Nature Works Grant. The application due date is June 1. The State budget has not passed as to notify what each county will receive. My opinion is if we pave the area by the BB Court/Tennis Court and make it exactly what it is we are not maximizing our investment. I think there is a better way to change that use if it moving the skate park over there, put the BB Court on the Tennis Court or 2 BB Courts. Or simply the walk path, making sure the walking path is in good condition. Which would council like to see happen. Justin stated the walking path due to more people using it. Matt likes the BB Court in Waynesburg. I have not had one person approach me regarding the Tennis Courts. Matt suggested eliminating the Tennis Court and make it a BB Court with nice hoops and make the current pad used for BB into the skate park. Benjamin stated we need to prioritize. The walking path is being used the most. Tim stated I would rather see improvements to the walking path. Nate stated they came and threw a huge fit and no work has started for improvements. I suggest it be a Dog Park! Forget the soccer field. Minerva Jail Renovation, \$20,000 An ordinance will be on tomorrows agenda to close the jail. This is from a liability and cost factor. Matt stated I think that is a good idea. Tim stated he thinks he sent four people to a jail term for OVI's. Loan Repayment \$8,900. K-9 Police Cruiser.

possible donations, but its great upfront, but once that money runs out, but there is still ongoing cost. One of them being is the office that handles the Canine is paid 2 hours of overtime each day for the responsibility of the dog. They also have a cruiser that they take to and from work due to the canine being with the officer at all times. All of this additional cost we have to figure in. If there are grants to offset it, great, so this gives us a whole year to tackle this stated Benjamin. I told Chief that I would like to plan on budgeting the vehicle, but I would like all other purchases from grants or donations. Mason stated for me, someone is going to have to show me how that is needed in this village. I just don't see it. Matt asked if it were a moral booster. Benjamin stated yes. Mason responded I do not care about moral that is way to much money for moral! Buy Pizza every Friday if we are boosting moral! Benjamin stated I agree with you. We said that to Chief, all surrounding counties have dogs, but none of them send the dog down here. Stark County made it clear they will not send the dog down here. If there are drugs, we know we will not get a dog. My comment was if we know that why are we taking a leap of faith to get a dog, when no one else has one, right! Why is that we are doing that? It certainly a moral booster. It's an expensive one. Matt stated we don't have the cartel around here that we need a drug sniffing dog! Patti stated your old neighbor! Benjamin stated it still could be used from a collaborative sort of angle with the surrounding departments for mutual aid and developing those relationships. In terms of actual revenues & expenses it will never pencil out. Mason for me my vote on that I would need to see a lot of it's a lot of money and I am sure it is needed. Benjamin stated I agree. Nate stated this would replace a vehicle. Benjamin stated no this would be additional. Tim stated this is not a vehicle you could give to another officer. Zero Turn Mower, \$40,000 Skid Loader \$40000 Loan Repayment \$8,900.

Revenues \$3550.00 Expenses \$3072.00. Tim stated we have to make a decision. Benjamin stated the Land Bank offers an option of 50/50 to tear it down. Mason asked if it were an option to sell it.
