The 12th Regular Council Meeting was called to order by Mayor Timothy N. Tarbet after the Lord's Prayer & Pledge of Allegiance were said.

Councilman Boldizar asked Chief Stoller if he had an update on the ambulance. Chief Stoller stated hopefully August-September.

Service Director: Street Dept.: Repaired tractor. Changed banners. Replaced damaged pole cover at N. Market St. @ US 30. Paving proposal attached as well as background information.

Water Dept.: Meter replacement ongoing, 1343 installed as of last week. Scheduling and planning new service tap on S. Grant. Ordered materials for new service tap on W. Line St.

Wastewater Dept.: MLSS has been increasing, increased wasting and pressing.

Park Dept.: Sprayed weed control uptown, Chase property and PD. Repaired wastewater Steiner (hydraulic leak) and replaced mower spindles. Trimmed trees in Bicentennial Park. Replaced lights in Bicentennial Park. Installed rubber mulch at new curly slide. Cleaned up homecoming grounds daily. Tear down of homecoming grounds.

Mr. Gunderson stated this allows the village to submit for OPIOD Settlement money through the Kroger Settlement. There have been many settlements. This is an opportunity for the village to seek revenues and to come up with a plan to expend those revenues.

Some things come up like an unexpected cost like the culvert or a donation given for the pickleball courts. It is essential that this appropriation change show those changes.

Mr. Gunderson stated in 2023 the village purchased the Chase Bank Building as well as the parking lot, the intent from the start was to separate the parking lot to create more public parking spaces. So, this is simply separating the lots from the building as we look to facilitate economics development. All voted yea. Motion to approve first reading of Ordinance No. 41-24 was made by Councilman Boldizar seconded by Councilman Kishman. Motion to suspend statutory rules and have second & third readings by title only of Ordinance No. 41-24 and for passage was made by Councilman Meadows seconded by Councilman Kishman. All voted yea. Councilwoman Jordan announced a farmers market will be held in Malvern tomorrow in the park. Councilman Meadows announced the Murder Myster Dinner will be held this weekend at the Community Building. 2nd Friday July 12th. Councilman Meadows thanked everyone that helped in any way with the Homecoming! Councilman Kishman announced a Park Board Meeting will be July 8th @ 6PM at Municipal Park. Councilman Boldizar stated this was one of the better Homecomings that I can remember. I enjoyed the other side. I thought it was great. Aaron asked if there were any unresolved annexation issues. Everything that we have given water & sewer to have annexed in? Mayor Tarbet stated I know what my answer is, but that's not what counts. Mr. Gunderson stated we are still working through the process with Linkins. It went before the BZA. We have taken the stands we are not going to annex them for reasons related to the business so they will continue to pay outside water rates. Aaron stated he received a notification from ODOT regarding the walking path bridge going to affect the Homecoming. There letter is open ended on the length. Mr. Gunderson stated we have made it clear that there is upcoming stuff related to the Homecoming and we let them know. At this point the bridge is not 100% funded, so I think that was more of a proactive/letter email to make sure everyone was in the loop. We know that is a heavily traveled bridge.

Aaron since the ordinance was passed, I would like clarification so when we did the appropriation change and talked about the gas & oil money coming in as a bonus, did all of that money go to the downtown entertainment district or did it get divided up amongst other things? Mr. Gunderson stated it was earmarked for the downtown entertainment district. Aaron asked what will that get us? That \$100,000? Mr. Gunderson responded that will get us a good portion of the way to the what we believe will be the final cost. Aaron asked so engineering? Mr. Gunderson stated that will be part of the final cost.

Mayor Tarbet said for the first year of handling the Homecoming went fairly smooth! I think the addition to across the creek added a new realm to the Homecoming.

Motion to adjourn was made by Councilman Boldizar seconded by Councilman Kishman. All voted yea.
