11th REGULAR COUNCIL MEETING

JUNE 10, 2025

The 11th Regular Council Meeting was called to order by Mayor Mason Boldizar.

Roll call was taken. All Council members were present. The Lord's Prayer & Pledge of Allegiance were said.

Motion to approve the Minutes of the 10th Regular Council Meeting held May 27, 2025 was made by Councilman Meadows seconded by Councilman Harris. All voted yea.

Motion to approve the financial statement for the month of May was made by Councilwoman Jordan seconded by Councilwoman Coe. All voted yea.

Motion to approve bills totaling \$170,776.58 for the month of May was made by Councilman Harris seconded by Councilman Meadows. All voted yea.

This will be for ages 8-14 and will utilize the swimming pool, the park and neighborhoods and end up at the track. We have been continuing with website updates. Law Director: No Report Mayor: No report Introductions of Legislation Containing Statement of Emergency: none First Read: Ordinance No. 31-25 an Ordinance approving the purchase of a second Columbarium Niche for the East Lawn Cemetery of the Village of Minerva, Ohio. First reading Motion to hear first reading in full and for approval of Ordinance No. 31-25 was made by Councilwoman Coe seconded by Councilwoman Jordan. All voted yea. Administrator Mytinger explained that this is the columbarium at East Lawn Cemetery. We chose the straight orientation, 48 niche, at a cost of \$41,319.00. Ordinance No. 32-25 an Ordinance amending the hours of operation of the Designated Outdoor Refreshment Area. First reading Administrator Mytinger explained this will make the DORA hours every Friday-Sunday from 11 AM to 10 PM annually. Motion to hear first reading in full and for approval of Ordinance No. 32-25 was made by Councilman Meadows seconded by Councilman Harris. All voted yea. Ordinance No. 33-25 an Ordinance amending Section 2 of Ordinance No. 61-24 to establish compensation rates for full-time and part-time employees of the Village of Minerva. First reading Administrator Mytinger explained that this is our annual pay ordinance. It updates the wages of some of the previously agreed upon salaries and wages. This would make changes to the annual wage for the Finance Director as well as the Mayor's and Council's monthly stipend and an increase for the school crossing guards. Motion to hear first reading in full and for approval of Ordinance No. 33-25 was made by Councilman Meadows seconded by Councilwoman Jordan. All voted yea. Motion to approve the DORA request of the Minerva Area Chamber of Commerce for June 11, 2025 from 4 PM to 10 PM for the Minerva Homecoming Parade was made by Councilman Harris seconded by Councilwoman Coe. All voted yea. Mayor Boldizar reported that Homecoming Parade starts at 6:00. He encourages everyone to support the Homecoming. There will be a beer garden, live music, events nightly. He appreciates the service guys as the park Councilwoman Jordan reported on the Park Board meeting. They are further discussing a dog park and the North Councilwoman Coe said that the parks look nice. She congratulated Councilman Meadows on being voted Person of the Year. Councilman Harris asked people to come down and enjoy the parade. He noted that as temperatures rise, asphalt gets hot for a dog's feet. He encouraged people to come to the Rotary booth at the Homecoming to buy tickets to win a cash prize and you can get your picture taken with Bill Pilati if he's there. Councilman Meadows has been working hard on the Homecoming. Parade registration is still open. Singo will be at the Community Building nightly. There is no money involved, but there are prizes. An ATM will be available near the Lions Pavilion. There will be a Cruise-In Thursday night and different bands every night. A Tug-of-War across the creek will take place. A Power Wheels Derby and AIW Wrestling as well as other events will take place. A beer garden will be open but people must stay in the roped off area. Mayor Boldizar congratulated Councilman Meadows as Person of the Year. He also mentioned the Alumni Hall of Fame Induction Dinner where Mayor Tim Tarbet and Jim Crouse will be inducted. Motion to adjourn was made by Councilman Meadows seconded by Councilman Harris. All voted yea. The next Regular Council Meeting will be June 24, 2025. Attest
